

# Privacy Policy

At My Ant Diary (“**My Ant Diary**” “**we**” or “**us**”), we are committed to protecting your privacy and keeping your information safe. My Ant Diary processes information about you in a few different ways. This Privacy Policy explains how we collect, use, disclose and keep information that can identify you (“**Personal Information**”) when you create a My Ant Diary account and use myantdiary.com (the “**Site**”), or our mobile applications, to post content to the My Ant Diary community, including diaries you create, comments and messages (the “**Services**”).

Note that our [Terms of Use](#) apply to this Privacy Policy. By creating an account with My Ant Diary, using the Services, or submitting any Personal Information via the Services, you are consenting to the collection, use and disclosure of your Personal Information as described below in this Privacy Policy. If you do not consent to the use of your Personal Information in these ways, please stop using the Services. This is important; we hope you will take time to read it carefully.

## Laws that incorporate this privacy policy

This privacy policy is adapted to Spanish and European regulations in force regarding the protection of personal data on the Internet. In particular, it respects the following rules.

- The Organic Law 3/2018, of December 5, of Protection of Personal Data and guarantee of digital rights.
- Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and the free movement of such data (RGPD).
- The Royal Decree 1720/2007, of December 21, by which the Regulation of development of the Organic Law 15/1999, of December 13, of Protection of Data of a Personal Nature (RDLOPD) is approved.
- Law 34/2002, of July 11, on Services of the Information Society and Electronic Commerce (LSSI-CE).

## What is Personal Information?

"Personal Information" is any information that can identify you. This may include, but is not limited to, your name, email address, Internet Protocol (“IP”) address, age and gender.

## **What do we collect and Why do we use it?**

If you're just browsing our Site, we don't collect any Personal Information about you. In order for you to create an account with My Ant Diary and use our Services, we need to collect and process some Personal Information. Depending on your use of the Services, that may include.

We treat the personal information above as private by default, so it won't be displayed on the Site (unless you choose to publicly display applicable information via your account settings), revealed to other My Ant Diary users, or rented or sold to anyone unless the data has been anonymized.

Except for your email address, which is required to create your My Ant Diary account, you can always opt not to disclose any Personal Information to us, but then you may be unable to use certain features on the Services.

## **Why do we collect and use your email?**

We use email as an important way to communicate with you. However, please note that in all cases you will continue to receive all system e-mails (e.g. those regarding forgotten user passwords) and legal notices (e.g. updates to our policies) from us.

## **What can other My Ant Diary users see?**

Our Services are designed to help you share information with the My Ant Diary community. Any personal information that you voluntarily choose to include in a publicly accessible area of the Service will be available to anyone who has access to that content (including other My Ant Diary users), such as your username, name, the description you create, and your location, as well as the messages you post, whether on your profile, to other users, people you follow, diaries you write, and many other bits of information that result from your use of the Services.

We may use this information to make inferences, like what topics you may be interested in, to develop new products and services for the My Ant Diary community, and to customize the content we show you, including ads. Our default is almost always to make the information you provide through My Ant Diary public to the rest of the My Ant Diary community, but we generally give you features, like direct messages, to make the information more private if you want.

## **How do we share your Personal Information?**

We may share your Personal Information with third-party service providers, but only where it's necessary to provide any of the Services to you (e.g., email providers, server providers, etc.). When we share data with third-party services that support our delivery of the Services, we require that they protect your Personal Information to the same standards we do.

We do not and will not release, rent or sell your Personal Information, except in the following very limited situations:

- To comply with an applicable law (including investigations of any crime), regulation, legal process or enforceable governmental request.
- To enforce or apply our Terms of Use and other policies, including investigation of potential violations.
- To protect the rights, property, or safety of My Ant Diary, our users, or the public.
- If My Ant Diary is involved in a merger, acquisition or asset sale, in which case we will continue to ensure the confidentiality of any Personal Information and give affected users notice before Personal Information is transferred or becomes subject to a different privacy policy.

## **Where do we store your Personal Information?**

Our Services are mainly provided from Spain. However, Personal Information that you submit through the Services may be transferred to countries other than where you reside (for example, to our servers in Germany) for processing and storage. In addition, our third party service providers also may process or store your Personal Information on servers outside your country.

By using any of the Services, or submitting any Personal Information via the Services, you authorize My Ant Diary and its authorized service providers to use and process your Personal Information in these countries. Please be aware that the privacy protections and the rights of authorities and Government agencies to access your personal information in some of these countries may not be equivalent to those in your country.

## **Access to your personal information**

If you wish to access any Personal Information that we hold about you, or request that we correct or delete the Personal Information that we hold about you, you may contact us via email at [privacy@myantdiary.com](mailto:privacy@myantdiary.com). We will comply with such requests to the extent required by law or our policies, and subject to any limitations in our systems.

To access, modify or delete the Personal Information you have provided to us, please log in and update your profile.

## **How does My Ant Diary protect my Personal Information?**

We are continuously implementing and updating physical, organizational, contractual and technological security measures to protect your Personal Information from loss, theft, unauthorized access, disclosure, copying, use or modification. On all My Ant Diary platforms, we support encryption on all transmissions to protect Personal Information submitted on our Site.

## **What happens to your Personal Information when you leave My Ant Diary?**

If you choose to delete your account, we permanently delete your Personal Information from our systems.

It is possible that the content you delete will be kept for a limited time in backup copies, and will remain visible if others have shared it on other sites.

## Non-personal information

My Ant Diary uses tracking pixels and similar technologies on our Service to collect information that cannot identify you as an individual (“**non-personal information**”) that helps us provide our Service to you and to learn how our Service is used. We also use these technologies to help deliver promotional messages and ads for relevant My Ant Diary products and services.

We may share non-personal information publicly and with various third parties like publishers or advertisers. For example, we may share information with advertisers or publicly to show trends about the general use of our Services.

## Claims - Supervisory authority

In the event that the User considers that there is a problem or infringement of the current regulations in the way in which their personal data are being processed, they will have the right to effective judicial protection and to present a claim to a control authority, in particular, in the State in which he has his habitual residence, place of work or place of the alleged infringement. In the case of Spain, the control authority is the Spanish Agency for Data Protection (<http://www.agpd.es>).

## Changes

Our Privacy Policy may change from time to time. We will not reduce your rights under this Privacy Policy without your explicit consent; in other cases, please note that your continued use of the Services after any change means that you agree with, and consent to be bound by, the revised Privacy Policy. If you disagree with any changes in this Privacy Policy and do not wish your Personal Information to be subject to the revised Policy, you will need to close your account and/or stop using the Services.
